ORDER PAYMENT. All orders must be prepaid with credit card. Personalized orders are charged at the time of proof approval. Cash and Carry orders are charged at the time of shipment.

PRICES. All retailers are required to sell all Haute Papier products at no more or less than 100% mark-up from the wholesale price. Non-compliance of this will result in cancellation of all unshipped orders of product. Seller's prices are subject to change without notice prior to seller's acceptance of an order. Prices exclude all taxes, duties and other governmental fees, freight and insurance costs. All such costs not included in the invoice to buyer are the responsibility of the buyer.

SHIPPING AND RECEIVING. All products ship directly from Haute Papier at buyer's risk and expense. Upon delivery of products to carrier, title and risk of loss or damage shall be buyer's. Check all orders carefully. Adjustments must be made within 48 hours of submitting an order. Orders may not be cancelled. Haute Papier will, at their discretion, accept returns of non-personalized items; the purchaser is responsible for return shipping and a restocking fee of 20% of the merchandise or \$15, whichever is greater.

CANCELLATIONS. Once a proof has been laid out, the cancellation fee is \$50. If an order has been approved, cancellations cannot be accepted. Orders remaining in the proofing stage for 30 days will be automatically cancelled and the cancellation fee will be charged. Once a deposit has been paid for a personalized collection, cancellations cannot be accepted.
